Education Policy

The Education Policy at Clairvaux MacKillop College is to maintain a Catholic Christian Learning Community where appropriately qualified teachers engage with students to foster self-directed learning, and the acquisition of knowledge, attitudes and skills that will assist them to contribute positively to society. Staff work to equip today's youth with Christian values to face the challenges of an ever-changing world.

Purpose

This policy on education at Clairvaux MacKillop College, together with associated principles, guidelines and procedures, informs decision-making and action, and describes our educational accountabilities.

Rationale

Clairvaux MacKillop College, as a contemporary Catholic Learning Community, recognises the need for students to be 'Lifelong Learners'. The provision of a varied curriculum that is both relevant and appropriate provides all students with the opportunity to experience successful learning within a safe and supportive environment.

Teaching and Learning

We acknowledge that education involves students, teachers and administrators working together as a learning community. As members of this learning community, we strive to reflect upon our learning by continuously reassessing and seeking to improve upon our practices in the pursuit of teaching excellence for the benefit of our students.

Incorporating a Learning Framework that is founded on explicit teaching practices and the thinking skills model to guide teaching and learning, we seek to be innovative and collaborative, and offer a curriculum that aims to cater for the needs, interests and abilities of our students and the Community.

At Clairvaux MacKillop College there is an understanding by teachers that learning is about transformation, and transformation is the basis of enhanced learner performance. Effective learning takes the learner on a journey into new and unfamiliar terrains. However, for this learning to make a difference in the life of students they need to be encouraged to venture in to the unfamiliar, the area of new knowledge and to feel confident that they have the skills to turn this new knowledge into something useful and relevant to them and their communities.
